6:40 Reports:

Chair's Report - Update & request names for Committee openings

Chair Janie Emerson stated that there are two committee openings for both La Jolla Shores Traffic and Transportation Committee and LJ Shores permit review committee that need representation from LJSAA.

Treasurer's Report – LJSAA new bank is Union Bank. Pam Boynton, Treasurer, will be added as a signer when the May Minutes are approved.

Donation box was offered and passed around the room

Public Comment: non-agenda items (2-minute limit)

Lorraine Smallenburger (sp? did not sign in), with the LJ Shores Surfing Association, spoke about the club and its efforts to protect the surf zone. They are advocates and do fundraising on behalf of the Friends of La Jolla Shores for future beach improvements.

6:50 Representatives' Reports:

City of San Diego Parks & Rec Department, Dan Daneri – San Diego Park & Rec Representative spoke about the City of San Diego Parks and Rec Master Plan

Presentation concerning Park & Rec overview plan for Department of Park and Rec Committees. The city is holding 10 workshops in San Diego to learn about the city's master plan. The last master plan from the city of San Diego was completed in the late 1950's!

Park and Rec manages over 42,000 acres. Discussion about the upcoming area workshops for community feedback.

Cost of consultants to make the plan for the city is several million dollars.

Board member John Sheridan asked about additional time for Rangers –

Dan talked about the permitting process – "if the city approves a permit, they may not be required to approach the LJSA for consideration.

Chair Janie Emerson asked that the LJSA be made aware of any special events within the La Jolla Shores and park areas.

San Diego City Lifeguard Report Lt. Rich Stropky – A very active beginning to the summer for SD City Lifeguards.

Meetings with Kayak concessions and surf camps prior to start of summer. It is a pleasure to work with the concessionaires.

The Board asked about Kellogg Park enforcement. They specifically asked about the Ambassador Program. Liz Palmer is one of the ambassadors, and will be back this summer.

Slacklines - Dave Gordon noted that he saw the lifeguards stop the slacklines. Law enforcement was asked about the illegal use of slack lines in the parks.

San Diego Police Dept. Officer. Larry Hesselgesser – Commented on the recruitment of new officers for the SDPD, reporting 15 new recruits recently.

The SDPD is still short 250 officers and retirement is at a fast pace but they continue to the best they can. ScDPD wrote 200 citations on Memorial Day for scooters not wearing helmet, riding on sidewalk, riding double. They are using municipal codes requirements to issue these citations. All SDPD calls are prioritized by level of crisis, so they write these citations as available.

Terri Krazewski asked if you could be ticketed for moving the rental bicycles. Off. Hesselgesser - You cannot get in trouble for moving them.

Council District 1 Mauricio Medina – passed out the Bry Bulletin –
City Hall update:

Wed June 20th at 9am - Budget Committee will include discussion of Dockless bikes and the Emergency Ordinance which was voted down. Felt that it is so new we are seeing the initial disruption.

John Sheridan – Inquired if there were available discretionary funds that the Council District Office has for the nightly locking of the gates at Kellogg Park. It was noted that the new fiscal year starts July 1st. Chair Emerson said the LUSA will take up Budget priority requests at the July & August meetings.

UCSD Representative Report Anu Delouri/Bob Brown – Commencement is this week. UCSD Chancellor will be the keynote speaker. Long range development plan is always topic of discussion. Anu said that the goal of UCSD is to have 65% on campus housing.
