## **Swear in New Board Members – Joe LaCava, Council District 1**

Pam Boynton, Janie Emerson, Rick Kent, and Terry Kraszewski were sworn in as new (or returning) Board member by Joe LaCava. Sharon Luscomb was unable to attend and will be sworn in next month.

Joe also reported they are expecting the city revenues to increase as we get back to more normal conditions after June 15<sup>th</sup> due to Covid. Mayor signed the Short Term Vacation Rental (STVR) ordinance into law. City Council approved new emergency medical services provided by Faulk. New preliminary budget from Mayor expected tomorrow. Final budget takes effect 6/30/21.

## SDPD Report - Officer Brandon Broaddus

5 brand new officers from Academy have been assigned to Northern Division. Allows 4<sup>th</sup> beach team. Capt. Novack says they will focus their attention on the northern beaches including La Jolla Shores. Asked if gates at Kellogg Park are being locked. Keys asked how many vendors are going to be allowed on the beach/boardwalk? Answer is CA passed Safe Vendor Act. City has not rewritten their Vendor Act to comply with CA requirements.

## **Lifeguard Report - Lt. Lonnie Stephens**

Continues to be a busy spring at La Jolla Shores. Remind people to always swim near a lifeguard. Upstaffing with seasonal lifeguards. March - 165,000 people Preventative measures – 2,400 actions. 20 water rescues, and 6 cliff rescue. Brian asked what the cost is for a cliff rescue? Is it paid by tax payors or the individual? Lonnie will get info for next month.
