**President's Report – Janie Emerson**

Comments included concern about trash issue with seagulls; Coastal Commission beach impact zone concerning street dining; dog waste on The Map.

**SDPD Report - Lt. Brian Brecht**

Shift change with an additional seven officers to supplement day beach teams and a presence at Kellogg Park.

Comments included clarification between SDPD and UCSD Patrol, which is responsible only for campus related matters; interactions with dogs off leash.

**Lifeguards – Capt. Maureen Hodges**

Adding staff with full summer staffing by mid-June through early September. Increase in cliff calls. Crowds steadily increasing. City's Dept. of Real Estate & Airport Management (DREAM) will contact LJSAs before Kayak RFP and Surf RFP expire next year.

State budget highlights: no cuts to core programs including education; preserves budget reserves; childcare rate enhancements; augments California Dream for All program for first-time homebuyers; tax cuts for small businesses and renters; expands upon California income tax credit. Negotiations with State Assembly before budget is finalized on June 15.

**Council District 1, Joe LaCava – Steve Hadley**

Steve acknowledged \$2 million which Senator Atkins obtained for the Spindrift stair repairs.

La Jolla Parkway project grinding down three inches of road and replacing with new section of fiber-reinforced asphalt overlay. This \$2.1 million project covers two-mile stretch. Slurry seal and restriping continues in the Village. With the digging of the streets and conduit installation winding down, the La Jolla Shores Undergrounding project is now at the beginning of the end. There is still almost two more years of work until all the poles can be removed. After the City installs streetlights, curb ramps, crosswalks then repaving will occur.

Virtual budget townhall meeting on May 11.

Comments included slurry seal around restaurant dining on streets; Hillside Drive being regraded so that slope is not so steep; unsafe streets for bicycles.

## Shores Street Lights – Jie Xiao

Civil Engineer Dayue Zhang reported that the lanterns approved by the LJSB Board in September 2022 are no longer eligible because they do not comply with the City's "dark sky" resolution. 37 new streetlights will be installed as part of the undergrounding project. Discussion included frosted or clear globe, light diffusion, globe style, quality of anti-graffiti coating to ensure it does not cloud, rusting.

**MOTION:** Select the Spring City brand lantern in silver fixture with frosted acrylic.

**MOTION:** Ask the City to return with a simpler globe design with the possibility to modify the acrylic frosted globe previously approved to comply with dark sky regulations.
