PRESENTATIONS

Spindrift/Marine Room Beach Access – Kathleen Neil

Working group met on Sept. 29. They reviewed a written report from CD1 regarding the Capital Improvement Project Review team stating that the project does not require City Council approval. The CIP currently has funding of \$100,000. A soils report bid from Christian Wheeler was reviewed. Information regarding a professional site survey resulted in the decision by the group that a formal survey of the walkway likely would not resolve important underlying issues and it was decided not to pursue a formal survey at this time.

Kurt Hoffman showed detailed measurements of the current condition of the walkway and a drawing depicting the current condition, with two possible approaches to improving it.

The working group will look at historical records for further background work and likely try to proceed with a Right of Entry type project. The soils report will be an important source for planning purposes.

Shores Outdoor Dining Update – Darren Moore

Complete presentation for proposal for Avenida de la Playa replacement parking will be made at the November meeting. Working with the City of San Diego for a beautification and street closing project after the Special Event Permit expires.
